Rules:

1. All rafts must be hand made. No commercial productions will be allowed.
2. No motors of any kind can be used.
3. No reconstructed boats or watercrafts allowed.
4. The raft's main body width can not be less than 1/3 the length.
5. Teams must consist of 2-4 members.
6. All participants must wear a commercially produced life vest at all times.



Waiver of Liability

Waiver and Release. I, and/or the minor registrant (respectively, “Registrant” and “Guardian”), do hereby release and forever discharge and hold harmless Dixon Petunia Festival, Petunia Festival Board and Corporation, their agents and assigns, officers, employees, directors, hosting organization and affiliated individuals (collectively, “Dixon Petunia Festival”), from any and all liability, claims and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Registrant’s participation in the River Raft Race. Registrant and Guardian understand that this Release discharges Dixon Petunia Festival from any liability or claim that the Registrant or Guardian may have against Dixon Petunia Festival with respect to any bodily injury, personal injury, illness, death or property damage that may result from Registrant’s participation in the River Raft Race, whether caused by the negligence of Dixon Petunia Festival. Registrant and Guardian also understand that Dixon Petunia Festival does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health or disability insurance in the event of injury or illness.

Medical Treatment. Registrant and Guardian do hereby release and forever discharge Dixon Petunia Festival from any claim whatsoever that arises or may hereafter arise on account of any first aid, treatment or service rendered in connection with the Registrant’s participation in the River Raft Race.

Assumption of Risk. Registrant and Guardian understand that participation in the River Raft Race may include activities that may be hazardous to the Registrant, including, but not limited to, constructing Registrant’s raft from homemade items, using raft as a flotation device, floating down the Rock River and entering and exiting the raft on the Rock River. Registrant and Guardian hereby expressly and specifically assume the risk of injury or harm in these activities and release Dixon Petunia Festival from all liability for injury, illness, death or property damage resulting from the activities of the Registrant’s participation in the River Raft Race. Registrant and Guardian agree to hold Dixon Petunia Festival harmless and to protect and indemnify them from any and all claims, actions, demands, expense (including without limitation attorney fees) and costs (including without limitation court costs) whatsoever that may arise out of or relate, directly or indirectly, to Registrant’s participation or involvement in the River Raft Race.

Other. Registrant and Guardian expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Illinois, and that this Release shall be governed by and interpreted in accordance with the laws of the State of Illinois. Registrant and Guardian agree that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
